**Beverly Frazier, Senior Planner
Town of Ponce Inlet**

Give us a little background on where you are from, and how you arrived here. *I grew up in a small town in Virginia in the foothills of the picturesque Blue Ridge Mountains. I thought it was the most beautiful place on earth...until I visited Florida. After graduating from the University of Florida, my wanderlust led me north and eventually out west, but I never felt at home until I moved back about 10 years ago. I've heard that life is most vibrant where the ocean meets the land, and I couldn't agree more.*

Tell us about your family. *My immediate family members still live in Virginia where I grew up. We talk daily and visit as often as possible. I have an amazing extended family of friends here, plus my boyfriend and our furry four-legged "golden girls" Stella and Punky.*

How did you become a planner? *While living in St. Augustine, I worked for the Building Services Division in St. Johns County. After about a year, I was provided an opportunity to transfer to the Planning and Zoning Division where I accepted a Planner position to advance my career.*

What responses do people give when you tell them you are a planner? *"What do you do?" is a question I've been asked many times at family gatherings and when meeting new people. It's a great conversation starter to share insights into the planning profession and what planners do in various roles.*

What improvements would you like to see in the community you live or work? *I would like to see more engagement of the community providing input on the direction of policy and land use decisions. The collaborative experience of involving residents in the planning process can facilitate understanding of different views, provide support for change, and identify future needs of the community.*

What are your hobbies and how do you enjoy spending your free time? *I'm an outdoor enthusiast and spend as much time as possible enjoying the natural environment including boating, fishing, hiking, swimming and biking. I seek adventure and love to explore our beautiful beaches, local waterways, and state and national parks.*

What is your favorite part of your job? *My position with the Town of Ponce Inlet provides me the opportunity to work directly with residents in land use, environmental preservation, and development review. As I gain understanding of their vision, I look forward to guiding resolution of planning goals that will directly benefit the community.*

What is the least favorite part of your job? *I truly enjoy the challenging work - interpretation of regulations, consideration of opposing views, and understanding complex issues, but implementing a decision that is not supported by others is never easy.*

What are the goals you hope to attain in your planning career? *In the short term, I plan to complete AICP certification next year and start looking at graduate degree programs. As I further my career, I hope to be directly involved with preserving coastal communities and shaping policy for sustainability in the face of sea level rise*

Mr. Kyle Wilkes, Senior Planner City of DeLand



Give us a little background on where you are from, and how you arrived here.

Originally from Michigan, I completed an undergraduate Degree in public administration and public policy, as well as my master's degree in urban and regional planning, at Michigan State University. I have lived in Florida since 2008, working as a planner at the city and county level throughout Central Florida. I am excited to join the city of DeLand as a senior planner and be a part of the great Community Development team, working in a vibrant downtown that is truly one of the jewels of our region, and a city steeped in history.

Tell us about your family. I am grateful to have most of my immediate family living in the Central Florida region, with the exception of my sister, who lives with her family in Okinawa, Japan. I have one fur daughter, a yellow lab named Bella. (Kyle and Bella are pictured in photo above)

How did you become a planner? I have been interested in geography, cities and urban form since I was a kid. I was enthralled with maps and an avid *National Geographic* reader growing up. However, it was not until I was a journalism major as an undergraduate that I decided urban planning was the profession for me, after being assigned to report on a local visioning and downtown revitalization effort. Ever since, I have been excited to help be a small part in helping to shape the future of the communities in which I live and work.

What responses do people give when you tell them you are a planner? Generally, people are quick to point out their concerns with growth and its impact on traffic, the environment or them personally. I try to explain the importance of urban planning in balancing all of these facets of growth, and encourage them to engage in planning process and in their local government, so that they can be well-informed with facts rather than hearsay, and so they can be involved directly in the process.

What improvements would you like to see in the community you live or work in? I think it's important that each of our communities in which we live and work in this region, many of whom are growing rapidly, to balance growth with revitalization efforts and supporting infill development and increased density to support our downtowns and small businesses, which help create and preserve a sense of place in each of our cities. In addition, we need to continue to work on the housing affordability Crisis in our region, so promoting alternative housing types beyond traditional, single-family residential will be critical for our residents as the sustainability of our communities and our economy.

What are your hobbies and how do you enjoy spending your free time? In my free time, you will usually find me walking and hanging out with my dog Bella, enjoying the beach, volunteering, reading or eating at locally-owned restaurants. Soon, I plan on taking up kayaking.

What is your favorite part of your job? I am a people person, so I enjoy being able to interact with a diverse group of people, from my co-workers, to members of the public, elected and appointed officials, as well as our applicants. In addition, I enjoy that each day is rarely the same. Working for a local government affords the opportunity to be involved along the entire spectrum of the planning process, from citizen inquiries to long-range planning and studies, to site plan approval, to public hearings.

What is the least favorite part of your job? It is often times being the mediator of conflict, between the forces of change and those who fear the impact that this will have on their way of life. Finding that diplomatic balance in the face of criticism can sometimes be difficult, but is also part of balancing sound planning principles with market forces and being a public servant.

What are the goals you hope to attain in your planning career? I hope to work at making our region a sustainable and vibrant place to live, work and visit. I am currently a doctoral candidate in the Leadership & Innovation program at St. Thomas University in Miami, learning and researching on ways communities can grapple with change, like growth and decline, and redevelop properties in environmentally-sensitive ways. I hope to apply these principles professionally and, in my community, while continuing to grow as a leader in the planning profession.

2020 PLANNING AWARDS

DEADLINE: September 30, 2020

It's time again for the Florida Planning and Zoning Awards! The FPZA Awards recognize outstanding land development and public/private sector planning statewide. For several decades, the awards program has been the centerpiece of FPZA's acknowledgment and promotion of best practices in planning throughout Florida.

FPZA encourages members to submit award applications. Projects must have been approved or completed during the last calendar year (2019). The categories are as follows:

Outstanding Development/Design Excellence: Newly planned, designed, or built "brick and mortar" projects that demonstrate superior form and function.

Outstanding Redevelopment: Reuse of a site, facility or structure.

Outstanding Study/Plan: Reports, studies, plans, documents, planning analysis, etc.

Infrastructure: Plans or projects that skillfully blend facilities or services into the community.

Innovation: Project or development that is unusual or ahead of its time.

Education: Plans or efforts that effectively promote planning and zoning best practices.

Grassroots/Non-Profit Initiative: Recognizes a nonprofit or neighborhood organization that has furthered the quality of life through the planning process within its community, such as: new or redevelopment, infrastructure, outreach, cultural events, education, health, festivals, tourism, and environmental.

Sustainability: Plans or projects that improve on and harmonize with the natural environment and reduce energy costs.

Outstanding Elected Official: Local, state or federal elected official who champions sound planning practices and accomplishes positive gains in areas of smart growth, environmental preservation, sustainable development, or equity planning.

Outstanding Journalist: Journalist who effectively and accurately puts forth information about planning and zoning issues to the public.

Outstanding FPZA Chapter: The chapter that increases or maintains their membership, achieves FPZA goals, and provides quality programs for its chapter members.

George W. Simons, Jr. Award: Candidate must be a current member of FPZA; evaluation is based upon the person's work and efforts over time, rather than just for the past year; and evaluation will also be based upon work directed towards the stated purposes, mission and goals of FPZA.

EVALUATION CRITERIA

Each award entry must state how the development, study, project, design, innovation, chapter or person meets one or more of the following purposes of FPZA:

- To promote cooperation among official planning and zoning boards and commissions, civic bodies, citizens, technicians and students interested in planning and zoning in Florida.
- To cultivate and stimulate interest in planning and zoning in the State of Florida.
- To encourage the observance of sound planning and zoning practices.
- To furnish information, advice and assistance to its members and provide a medium to exchange information, advice and assistance among them.
- To engage in research and issue publications on planning and zoning and related matters.
- To promote education concerning matters related to planning and zoning.



2020 PLANNING AWARDS

DEADLINE: September 30, 2020

In addition, each award entry will be judged based upon the following criteria:

Background: History or context within which the project is significant; indication of expenditure of time, type of personnel, budget, population and size of jurisdiction.

Innovativeness: Use of an original concept or refinement of an existing technique or procedure.

Effectiveness: Project/strategy impact on the subject matter.

Implementation: Project/Strategy method or application to the subject matter; adaptability to changing conditions; and consideration of and solution to practical constraints.

Comprehensiveness: Scope and consideration of project/strategy in relationship to all aspects of the subject matter.

Clarity: Clearness of the award entry application.

SUBMITTAL PROCEDURES

- A cover letter that states the name of the nomination, the award that is sought, the name of the recipient(s), and the name, phone number, address and email of the applicant.
- A brief summary to be used for ceremony purposes, if selected. (100 words or less)
- A brief description of the nomination for the award relevant to the award category. (500 words or less)
- A narrative of the nomination which clearly demonstrates the evaluation criteria, as outlined on page one (1) of this "Call for Entries" (1,000 words or less).
- Applicable images and graphics representing the projects, in JPEG or PDF format
- Letters of recommendation.

Nomination submittal packages on CD preferred but not required.


NOTE:

- For the Outstanding Journalist and Chapter Awards, in lieu of the above submittal procedures, only a one (1) page statement in support of the nominee is required, while further supporting information is encouraged.*
- For the George W. Simons, Jr. Award, the nomination application must be submitted by an FPZA member with a statement by FPZA member(s), however; additional endorsements included in the application may be from non-members.*
- The FPZA Awards Committee reserves the right to reclassify the category for any submittal.*

Award recipients will be announced at the Awards Ceremony scheduled for December 11, 2020. The FPZA State Awards are being combined with the Surfcoast Chapter's December Gala and will be held at Halifax River Yacht Club in Daytona Beach, Florida.
